President's Report



To My Fellow Members:

I am pleased to report to you the remarkable performance of our club for the Fiscal Year 2017-2018. Significant changes greatly improved the club's services and facilities and helped maintain its status as the premier club in Metro Manila.

Major projects undertaken during the said period include:

- 1. The construction of the San Antonio Function Room
- The building of Employees' cafeteria
- The improvement of the Employees' locker area
- The rehabilitation of bowling equipment
- The installation of new PABX system

Furthermore, the creation of the MSCI website, virtual tour, and fiber optic internet connection have given members and guests hassle-free internet access for their business and personal correspondence.

It is also important to note that the club ended fiscal year 2017 on a positive note with Php 2.4 million net income or 153% growth over last year. Worth mentioning also, is the quantum leap of 146% growth in food and beverage sales.

The increase in the Food and Beverage Department is attributed to many factors. Firstly, members' patronage increased by 10% in the various food outlets. The growth of sales in the various food outlets Club Delicatessen, Le Patisserie, and the Bistro Lounge contributed the most. Secondly, banquet sales increased by 22%. Finally, the F&B food delivered quality service while keeping the food cost at efficient levels. Skills training on customer service played a significant role on this.

To date, we also inducted 76 new members and processed 65 new applications for membership. As a commitment to promote a healthy and active lifestyle, the Sports Department launched different and invigorating sports activities such as the Indoor Triathlon, Swim Masters Challenge, Endurance 42K Run, Biggest Loser Competition, Ping-Pong and Bowling Tournaments, and the 7:00 AM Fitness and Wellness Challenge.

In closing, the club's notable performance is a concerted effort and cooperation made by all members and the management. The Board of Directors would like to express our gratitude and appreciation to all those who supported the club and helped realize its advocacies.







